BYLAW NO. 1127**

**A BYLAW TO PROVIDE FOR GENERAL STREET REGULATION AND FOR THE  
REGULATION OF ALL PEDESTRIAN AND VEHICULAR STANDING AND MOVING  
TRAFFIC WITHIN THE CITY OF DUNCAN.**

---

The Municipal Council of the Corporation of the City of Duncan enacts as follows:

**PART ONE**

**INTERPRETATION**

1. In construing and interpreting this Bylaw unless the context otherwise requires -
  - (a) The words “Angle-Parking” mean the parking of a vehicle at any angle of approximately forty-five degrees (45°) to the curb or sidewalk of a street;
  - (b) The word “Animal” shall mean and include, stallion, mare, horse, gelding, colt, mule, ass, bull, cow, calf, heifer, steer, ox, goat, sheep, lamb, kid or swine;
  - (c) The word “Boulevard” shall mean that portion of a public highway or street within the boundaries of the City of Duncan which lies between the traveled portion of the street or highway, and for the purposes of this bylaw, shall include any portion of the street or highway used as a sidewalk by the public;
  - (d) The words “Chief of Police” shall mean the senior resident member of the Royal Canadian Mounted Police in or near the City of Duncan;
  - (e) The word “City” shall mean the City of Duncan;
  - (f) The word “Council” shall mean the Municipal Council of The Corporation of the City of Duncan;
  - (g) The word “Intersection” shall mean the portion of any roadway which crosses a portion of another roadway, and where one roadway joins or runs into another roadway without crossing it, shall also mean and include the portion of such last-mentioned roadway which would be included in such first-mentioned roadway if the boundaries of such first-mentioned roadway were produced in straight lines, or if the roadway is curved, in straight lines tangential to its boundaries, across such other roadway from the nearest points where such boundaries are parallel;

- (h) The words “Loose Material” shall mean sand, gravel, stone or stones, earth, broken or crushed rock, coal, coal dust, ashes, manure, straw, hay, handbills, paper, confetti, shavings, sawdust, pieces or chips of glass, pieces or chips of wood or bark, garbage or other substances of similar description or nature;
- (i) The words “Parking Space” mean a space on a street indicated by lines painted or marked pursuant to this Bylaw on the ground or pavement of the traveled portion of the street or on the sidewalk;
- (j) The words “Parking Period” shall mean the periods respectively hereinafter specified that is to say:
  - (1)The period between the hours of nine o’clock in the forenoon and six o’clock in the afternoon of every day except holidays as defined by the Interpretation Act of the Province of British Columbia.
- (k) The words “Motor Vehicle” shall have the meaning assigned to that expression by the “Motor Vehicle Act”, being Chapter 253 of the “Revised Statutes of British Columbia, 1960, as modified, re-enacted, amended, and in force for the time being and the words “Motor Carrier” shall have the meaning assigned to that expression by the Motor-Carrier Act, being Chapter 252 of the Revised Statutes of British Columbia, 1960, as modified, re-enacted, amended and in force for the time being, and the words “Motor Carrier” shall have the meaning assigned to that expression by the Motor Carrier Act, being Chapter 252 of the Revised Statutes of British Columbia, 1960, and as aforesaid;
- (l) The words “No Parking” shall mean that no vehicle shall be stopped, parked, stationed or positioned in any space to which the words are applicable other than for the purpose of loading or unloading of any passenger and/ or goods. The words “Park”, “Parked” and “Parking” shall have corresponding contextual meanings and shall mean the standing of a vehicle whether occupied or not upon a street otherwise than temporarily shall be deemed to be continuously parked until it has been moved out of the City block in which it was originally parked and may not be returned to that City block within 7 hours of initial parking. (changed from “between 9:00 a.m. and 6:00 p.m. on the same day.)
- (m) The Words “No Stopping” shall mean that no vehicle shall be stopped, parked, stationed, or positioned in any space to which the words are applicable for any purpose whatever. The words “Stop”, “Stopped”, and “Stopping” shall have corresponding contextual meanings;

- (n) "The word "Owner" with respect to a vehicle means (i) The person who holds legal title to the vehicle or (ii) a person who is a conditional purchaser, a lessee or a mortgagor and is entitled to be in possession of the vehicle or (iii) the person in whose name the vehicle is registered. as outlined in Part 3, Section 119 of the Motor Vehicle act R.S.B.C. Chapter 318, 1997 and amendments thereto."
  - (o) The words "Parallel Parking" shall mean the parking of a vehicle parallel to the curb or sidewalk of a street;
  - (p) The words "Parking Meters" shall mean automatic or other mechanical meters or devices with the necessary standards for the same for the purpose of controlling the parking of any vehicle. The words "Parking Meter" shall mean any one of such parking meters;

- (q) The words "City of Duncan Bylaw Enforcement Officer or Peace Officer" shall mean and include an official appointed under the provisions of this Bylaw relating to the regulation of parking, parking meters, and the enforcement of this and other bylaws of The Corporation of the City of Duncan;
  - (r) The words "Person" shall include a corporation;

- (s) The words "play vehicle" without limiting the generality of the following means coaster wagon, scooter, roller-skate, skateboard, sled, toboggan, ski or skate and any other wheeled or runnered device propelled by human power upon which any person may ride but does not include a cycle.

- (s) (1) The words "Recreational Vehicle" shall mean a vehicle designed or used primarily for accommodation during travel or recreation.

- (s) (2) The words "Recreational Trailer" shall mean a trailer designed or used primarily for accommodation during travel or recreation.

- (t) The words "Police Officer" shall mean any police officer of the City of Duncan or other person having the authority of a police officer in the City of Duncan including a member of the Royal Canadian Mounted Police;
  - (u) The word "Public Place" shall mean and include any public square, street, highway, public garden, public recreation ground, public park, or boulevard within the City;
  - (v) The word "Roadway" shall mean that portion of a street, other than a sidewalk, which has been surfaced with asphalt, macadam, gravel or other hard material;

- (w) The word “Sidewalk” shall mean that portion of any street which has been surfaced with concrete, asphalt, ashes, gravel or other hard material and lies between that curb line and the nearest side of the street from the curb line, and in case there shall be no permanent curb line shall mean that portion of the street within six feet (6’) of the side thereof;
- (x) The words “Street” and “Highway” shall mean and include all public streets, highways, roads, alleys, lanes, bridges, boulevards, sidewalks and any other ways in the City over or upon which the public has the right of passage or access;
- (y) The word “Traffic” shall include pedestrians, ridden or herded animals, vehicles and other conveyances either singly or together while using any street for the purpose of travel;
- (z) The word “Trailer” shall have the meaning assigned to that expression by the said “Motor Vehicle Act” as modified, re-enacted amended and in force for the time being;
- (aa) The word “Bicycle” and “Tricycle” shall mean and include a bicycle or tricycle as the case may be propelled by muscular power.
  
- (bb) The word “Vehicle” shall include any carriage, cart, wagon, sleigh, sled, conveyance, bicycle, tricycle, motor vehicle as defined by the said “Motor Vehicle Act” as modified re-enacted, amended, and in force for the time being, and all other objects on wheels or runners, drawn or capable of being drawn or propelled by animal, human, or mechanical power, except the cars of electric or steam railways or other vehicles running only upon rails or tracks;
- (cc) The word “Weapon” shall include cannon, gun, rifle, air-gun, spring-gun, catapult, bow and arrow, sling-shot, pistol, revolver, shot-gun or other fire arm;
- (dd) The words importing the singular number or the masculine gender only shall include more persons, parties or things of the same kind than one, and females as well as males and the converse and any corporation to which the context may extend.
  
- (ee) The words “City block” shall mean the distance between two intersections (reference attached Exhibit “A”) in all areas of the City except that area defined in Exhibit “B” which is grouped together and considered as one City block; being North of Government St., South of and including Ingram St., East of Boundary St., and west of and including Canada Ave and the Train Station parking lot.
  
- (dd) The words “Micro car” shall mean a motor vehicle, including motorcycles, mopeds and scooters, with a maximum total length of 10 feet (3 m).

## **PART TWO**

### **GENERAL**

1. Except as and unless otherwise provided in this Bylaw, no person in charge, control or possession of any vehicle shall reverse the direction of the said vehicle by turning it around so as to proceed in an opposite direction to that in which the said vehicle is traveling in any street or highway.
2. Except as an unless otherwise provided in this bylaw no person in charge, control or possession of any vehicle shall back up the said vehicle in any street except for the purpose of moving the said vehicle to a stationary position parallel to and within twelve (12”) inches of the curb or side of the roadway of such street and on or in front of which position or of some part thereof such vehicle shall be so backed up, or for the purpose of moving said vehicle from a stationary position at the curb or side of the roadway into the line of traffic on said street; and no such person shall so back up such vehicle at any intersection;
3. No person in charge, control or possession of any vehicle shall reverse the direction of the said vehicle by making what is commonly known as a “U” turn in any street or highway.
4. Except where otherwise directed, only parking parallel to the street line shall be lawful;
  - (a) It shall be unlawful for any person to allow or permit a trailer to be or remain attached to any motor vehicle while such motor vehicle is parked in a street parking space;
  - (b) A vehicle utilizing a parking space shall be parked wholly within such space. Where angle parking is permitted, no vehicle shall extend into the street for a distance of more than sixteen feet (16’) measured at right angles to the curb. In the case of parallel parking a vehicle shall be parked so that its side nearest to the curb or sidewalk shall be within twelve inches (12”) of such curb or sidewalk.
5. No person in charge, control or possession of any vehicle shall park or permit the same to be parked in such parts of any street or highway prescribed by this Bylaw or any amendment hereto, or by any subsequent Bylaw as “No Parking” areas. A “No Parking” area may be so indicated either by the painting of a yellow line 6” in breadth from the outward extremity of that portion of the street or highway or restricted, and parallel to the street or highway, together with the words “No Parking” in yellow, or upon signs on standard erected adjacent thereto, or by so indicating upon a sign on a standard erected adjacent to a “No Parking” area. That

part of any street or highway designated by this Bylaw by Schedule H or any amendment hereto is a “No Parking” area.

6. No person in charge, control, or possession of any vehicle shall park or permit the same to be parked upon the streets or portions of streets prescribed by a painted yellow line 6” in width from the outward edge of the curb, and otherwise, that is to say:
- (1) On that part of the side of any street nearest to any property occupied by a Church during any period of worship therein;
  - (2) On that part of the side of any street nearest to and in front of any private driveway which has been constructed or is maintained in compliance with the requirement of this Bylaw;
  - (3) On that part of the side of any street nearest to and in front of any theatre, moving picture house, or public hall during the period that a performance, game, exhibition, lecture, concert, ball, entertainment or public assemblage whatever is in progress or being held therein;
  - (4) On that part of the side of any street nearest to any property occupied as a funeral under-taking establishment during the progress of any funeral thereon or therein.

7. No person in charge, control or possession of any vehicle, other than a public freight vehicle within the meaning of the provisions of the Motor Carrier Act, R.S.B.C. 1960, and being less than twenty-six feet in length, shall park or permit the same to be parked between the hours of 9 o’clock in the forenoon and 6 o’clock in the afternoon on any day of the week other than Sundays and public holidays upon the portions of the streets designated by Schedule “A” to this Bylaw as amended by resolution of the City Council.

Schedule B**

8. No person in charge, control or possession of a public freight vehicle within the meaning of the provisions of the Motor Carrier Act, R.S.B.C. 1960, and being in excess of twenty-six feet in length, shall park or permit the same to be parked at any time within the area designated by Schedule “B” to this Bylaw as amended by resolution of the City Council from time to time relative to the control of such vehicles. It shall be lawful for the Council for the purpose of enforcing the foregoing to place or cause to be placed signs upon such portions designated so worded as to indicate the prohibition enacted herein.

9. The areas which are defined and listed in Schedule “A” to this Bylaw as amended by the City Council from time to time shall each be constituted as “freight loading zones” for the purpose of permitting public freight vehicles and other commercial vehicles so designated by license and/or permit to stop, to actively load, and/or unload freight goods and merchandise within such areas between the hours of 9 o’clock in the forenoon and 6 o’clock in the afternoon for a period not exceeding fifteen (15) minutes, and such areas shall be distinguished by the painting of a white

line 6” in breadth from the outward extremity of that portion of the street or highway so restricted, and parallel to the street or highway together with the words “Freight Loading Zone” in white adjacent thereto.

10. The omission to paint the designatory words required by the various sections of the Part shall not render the prohibition indicated by the colored painted line in any area ineffective and a painted line alone shall be sufficient to render enforceable the prohibition indicated by its color.
11. No person in charge, control or possession of any vehicle shall park such vehicle or allow or permit the same to be parked in or upon any of the following places are areas, namely:
  - (1) Within any intersection or within fifteen (15) feet of any intersection;
  - (2) On that part of any street within fifteen (15) feet of any fire hydrant;
  - (3) On the side of the street nearest to and in front of any fire hall;
  - (4) On any boulevard which, where applicable, includes a sidewalk within the meaning of this Bylaw;
  - (5) On any street facing oncoming traffic.

12. (1) It shall be unlawful for any person in charge, control or possession of any vehicle to park such vehicle or permit the same to be parked in locations listed in Schedule “B”, Section 1 of this bylaw and as amended by resolution of the City Council, for a longer continuous period than (2) hours between the hours of Eight o’clock in the forenoon and six (6) o’clock in the afternoon on any day other than a Sunday and holidays as defined by the Interpretation Act of the Province of British Columbia.

(2) It shall be lawful for the Council to place or cause to be placed at each of the positions in this Section hereinafter mentioned a sign displaying the words “2 Hour Parking” in the areas defined and listed in Schedule “B”, Section 1 of this bylaw and as amended by resolution of the City Council.

(3) It shall be unlawful for any person in charge, control or possession of any vehicle to park such vehicle or permit the same to be parked in locations listed in Schedule “B”, Section 2 of this bylaw and as amended by resolution of the City Council, for a longer continuous period than (3) hours between the hours of Eight o’clock in the forenoon and six (6) o’clock in the afternoon on any day other than a Sunday and holidays as defined by the Interpretation Act of the Province of British Columbia.

(4) It shall be lawful for the Council to place or cause to be placed at each of the positions in this Section hereinafter mentioned a sign displaying the words “Customer Parking, Up to 3 Hours” in the areas defined and listed in Schedule “B”, Section 2 of this bylaw and as amended by resolution of the City Council.

(5) It shall be unlawful for any person in charge, control or possession of any vehicle to park such vehicle or permit the same to be parked in locations listed in Schedule “B”, Section 3 of this bylaw and as amended by resolution of the City Council, for a longer continuous period than (1) hour between the hours of Eight o’clock in the forenoon and six (6) o’clock in the afternoon on any day other than a Sunday and holidays as defined by the Interpretation Act of the Province of British Columbia.

**THAT under Part 2 – General – Section 13 be removed.**

14. The following streets or portions of streets are designated as Arterial Highways for the purpose of this Bylaw:
  - (1) Craig Street from the south boundary of the City, northerly to and including the intersection of Government Street and Craig Street;
  - (2) Government Street from the west boundary of Craig Street westerly to the east boundary of the Indian Reserve;
  - (3) That portion of Government Street which lies to the east of the intersection of Government Street and Craig Street;
  - (4) That portion of Trunk Road which lies to the east of the intersection of Government Street and Craig Street;
  - (5) The whole of Canada Avenue;
  - (6) All that portion of the Island Highway within the City;
  - (7) The whole of Kenneth Street.
  
15. It shall be lawful for the Council for the better regulation of traffic, to place or cause to be placed, signs or signals on or above the surface of any street in the City intersecting with any Arterial Highway designated as such by this Bylaw at or near the intersection of such street with an Arterial Highway making use of one or more of the following methods, namely:
  - (1) By displaying the word “STOP” on the surface of the said road.
  - (2) By displaying one or more raised safety stop sign or signals with or without lights or reflectors on the surface of the said street. Such signs or signals are hereinafter referred to as “STOP SIGNS” or in the singular as a “STOP SIGN”.
  
16. It shall be lawful for the Council for the better regulation of traffic to place or cause to be placed a sign or signal by one or more of the methods specified in Sub-section

(1), (2) of Section 15 of this Bylaw on or above the surface of the streets defined and listed in Schedule “C” of this Bylaw as amended by resolution of the City Council.

17. It shall be lawful for the City Council, for the regulation of traffic within the City and the prevention of immoderate riding or driving, to place or cause to be placed appropriate signs or signals upon the streets defined and listed and of the type and character designated on Schedule “D” to this Bylaw as amended by resolution of the City Council.
18. Pursuant to the Motor Vehicle Act in force and effect for the time being, and with the approval of the Assistant Commissioner of the Royal Canadian Mounted Police for the Province of British Columbia, it shall be lawful for the City Council to place or cause to be placed on any street signs displaying a statement of miles per hour indicating the authorized maximum rate of speed upon such street and the location of the termination of such rate with such further words of explanatory nature as the City Council shall see fit.
19. That portion of the land shown on Land Registry Office Plan Number 1721 lying to the east of Block One (1) as shown on the said plan is hereby designated as a One-Way Highway for vehicle traffic proceeding in a southerly direction only and no person in charge, control or possession of any vehicle shall drive such vehicle or permit the same to be driven on the said One-Way Highway except in a southerly direction and it shall be lawful for the Council to place or cause to be placed on the east side of the said One-Way Highway at or near the intersection of the said One-Way Highway with Coronation Avenue a sign facing south and displaying the words “DO NOT ENTER”.
20. (a) That all of Craig Street is hereby designated as a ONE WAY HIGHWAY for vehicular traffic proceeding in a northerly direction.  
(b) That all of Jubilee Street between Station Street and Kenneth Street is hereby designated as a ONE WAY HIGHWAY for vehicular traffic proceeding in a northerly direction only.

21. It shall be lawful for the Council to place or cause to be placed at each of the positions defined and listed in Schedule “C” of this Bylaw as amended by resolution of the City Council from time to time a sign displaying the words “MOTOR CARRIERS STOP”.

22. It shall be lawful for the City Council to place or cause to be placed a sign the words “CITY OF DUNCAN” or “CITY OF DUNCAN 30 MPH” at the positions defined and listed in Schedule “E” to this Bylaw as amended by resolution of the City Council from time to time.
23. The City Council may, for the better regulation of traffic, by resolution from time to

time, place or cause to be placed at such positions as it shall deem suitable a sign displaying the words “FIFTEEN MINUTES PARKING” or “THIRTY MINUTES PARKING” or “SIXTY MINUTES PARKING”, respectively.

24. In view of the frequent congestion of traffic in the following streets, that is to say:
- (1) That portion of Station Street lying between Canada Avenue and Jubilee Street;
  - (2) In that portion of Craig Street lying between Ingram Street and Government Street;
  - (3) In that portion of Canada Avenue lying between Trunk Road and the north boundary of Ingram Street extended easterly;
  - (4) In that portion of Duncan Street lying between Trunk Road and the north boundary of Queens Road extended westerly;
  - (5) In that portion of Kenneth Street lying between Craig Street and the westerly boundary of Canada Avenue;

Each of the said portions of the said streets respectively is hereby designated as a congested district and no pedestrian shall cross any of the said portions of the said streets respectively at any place other than between the parallel lines which are hereby authorized to be marked on the pavement at the street intersections or crossings respectively, in each of the said portions of the said streets respectively.

25. The Council may, for the better regulation of traffic, mark or cause to be marked the streets or portions of the streets defined and listed in Schedule “F” to this Bylaw as amended by resolution of the City Council from time to time, with distinguishing marking along the centre of the portion of such street set apart for vehicle traffic and the driver of any vehicle when traveling on any of the streets so marked shall ensure that such vehicle keeps to his right hand side of such distinguishing mark.

26. The driver of any vehicle when traveling on any street on which a Stop Sign has been placed pursuant to the Bylaw and schedule hereto or pursuant to an resolution of the City Council pertaining hereto shall when approaching and before passing such Stop Sign while at a distance of not more than Twenty Feet (20’) therefrom bring such vehicle to a stop.

27. The Council may, for the better regulation of traffic mark or cause to be marked crosswalks at all intersections where there is material conflict between vehicular and pedestrian movement and at other appropriate points where there is substantial pedestrian movement, and where pedestrians could not otherwise recognize the proper place to cross.
- (a) Crosswalk lines shall be solid white lines not less than four inches or more than nine inches wide *or brick/concrete pavers serving as crosswalks (am*

- August 29, 1982 p.250*) extending entirely across the pavement or roadway.
- (b) The width of crosswalk between crosswalk lines shall be determined by the width of sidewalks so connected or by predetermined width where no such sidewalk to be connected exists.
  - (c) A “STOP” line shall be used in conjunction with crosswalks where it is important to indicate the point where a vehicle shall stop in compliance with a traffic signal, a STOP sign or other specific requirements to stop.
  - (d) A “STOP” line shall be a solid white line, not less than 12 inches or more than 24 inches in width, extending from the right curb or pavement edge to the directional dividing line, or in case of one way streets to the left curb or pavement edge; and such line shall be marked on the approach side to the crosswalk not closer than one crosswalk line width and not more than three feet from the crosswalk line.
28. As a means of caution or warning to drivers of vehicles and generally for better regulation of traffic, the placing of signals of the character and in the locations defined and listed in Schedule “G” of this Bylaw as amended by resolution of the City Council from time to time, is hereby authorized.
29. The Driver of any vehicle approaching an intersection toward any green colored light affixed in accordance with Section 28 of this Bylaw shall proceed with the utmost caution throughout the intersection.
30. The driver of any vehicle approaching an intersection towards a red colored light affixed in accordance with Section 28 of this Bylaw shall bring such vehicle to a stop prior to entering such intersection and shall then proceed with the utmost caution throughout the intersection.
31. No foot passenger and no person in charge of a vehicle or animal when approaching a red or amber colored light affixed in accordance with Section 28 of this Bylaw shall enter or permit the vehicle or animal to enter the intersection until a green light shows in place of the red and amber lights.
32. Red colored caution lights installed above the centre of any intersection within the City of Duncan showing an intermittent red light shall indicate to the driver or operator of any vehicle that he or she shall bring the vehicle to a full standing stop before entering such intersection, and any driver or operator as aforesaid approaching any such intersection shall bring the vehicle to a full standing stop accordingly.
33. The Council may affix or cause to be affixed the name of any street at the corners thereof on either public or private property.

34. (1) With the exception of a vehicle coming within the category of the vehicles described in Sub-section (2) of this section it shall be unlawful for any person in charge, control or possession of any vehicle to park or allow or permit such vehicle to be parked upon any street within the area bounded by the Trans Canada Highway on the east; Coronation Avenue, Duncan Street and Evans Street on the north; the westerly boundary of the City on the west; Underwood Street, Government Street, and Cowichan Way North and East on the south in the City on any day during the period between the hour of 3 o'clock in the forenoon to the hour of seven o'clock in the forenoon. It shall be similarly be unlawful for any such person to park or allow a vehicle to be parked on any other street during these same hours in the City other than the area described in this sub-section when a sign displaying the words "NO PARKING 3 a.m. to 7 a.m. \_\_\_\_\_ DAY" is placed at such positions as the City shall deem suitable.

(2) With the exception of a vehicle coming within the category of vehicle described in subsection (3) of this section, it shall be unlawful for any person to park or permit to be parked a vehicle or trailer or any combination thereof having a gross vehicle weight in excess of 4500 kg, or a recreational vehicle, or recreational trailer, or any unattended trailer, on any street between the hours of 9 o'clock in the afternoon (2100 hours; 9:00 p.m.) and 6 o'clock in the forenoon (0600 hours; 6:00 a.m.) of the following day.

(3) (a) An ambulance for loading or unloading a patient;  
(b) A vehicle carrying rescue or first-aid equipment for and during its use in the vicinity of the place where the same is parked;  
(c) A motor vehicle driven by or in charge of a Police Officer or Constable in the discharge of his duties;  
(d) Any vehicle for the loading or unloading of persons for a period not exceeding ten consecutive minutes;  
(e) Any vehicle driven by or in charge of a duly qualified medical practitioner in the course of his professional practice while visiting a patient in the vicinity of the place where such motor vehicle is parked;  
(f) A vehicle owned by the Corporation of the City of Duncan while employed in the work or business of the said corporation.

35. It shall be unlawful for any person in charge, control or possession of any vehicle to allow or permit the said vehicle to stand or remain stationary upon any street in the City while the said vehicle is being displayed for sale or exchange.

36. No person shall drive a motor vehicle over or upon any sidewalk when entering or leaving any private property, garage, oil or gasoline station or any building without bringing such motor vehicle to a stop immediately prior to driving over or upon such sidewalk and ascertaining that no pedestrian is on such sidewalk and likely to be injured by the driving of such motor vehicle thereon.

37. No person shall, unless and except as in this Bylaw or in any Bylaw of the City otherwise provided, hinder or interfere with the traffic on or obstruct the free use of any street.
38. No person or persons shall be a member or members of or take part in any parade, march or procession of any kind or nature or public meeting or other demonstration of any kind or nature through, or on, any street, highway, public square or public place of the City without a permit therefor first had and obtained from the Council.
39. It shall be lawful for the Council to permit in writing any person to cause a temporary obstruction to any street for the purpose of parades, marches or processions of any kind or nature or public meetings or other demonstrations of any kind or nature upon such terms and conditions as to time, place, subject and regulation or otherwise as the Council shall specify.

40. (1) Without restricting the generality or limiting the meaning of the terms “obstruct” or “obstruction” as used in Sections 37 and 39, any person who lounges or loiters upon any part whatsoever of any street or who takes part or joins in any gathering of persons for street preaching, lecturing, or procession, shall be deemed to be obstructing, or causing an obstruction to the free use of the street.  
(2) Except as otherwise permitted in 40.(3) and 40.(4) and without restricting the generality of the meaning of the terms “obstruct” or “obstruction” any person who causes or permits any goods, wares or other article of trade or commerce to remain on any part of any street longer than is reasonably necessary to deliver expeditiously or remove the same into any premises or vehicle shall be deemed to be obstructing, or causing an obstruction to the free use of the street.  
(3) Merchandise tables and display apparatus are permitted on public sidewalks in accordance with the following:
  - (a) merchandise tables or display apparatus are permitted for each business with street frontage and where a business fronts on two streets, tables or apparatus are permitted on each street.
  - (b) Each merchandise table, display apparatus or combination thereof shall occupy a maximum area of 3.7m (40 sq. ft.) for each street frontage.
  - (c) A minimum width of 1.2m (4’) of public sidewalk must be left fully clear and unencumbered.
  - (d) The merchandise tables or display apparatus may only be placed on the public sidewalks during the hours when the business is open.
  - (e) The owners of the merchandise tables or display apparatus must formally indemnify and hold harmless the City of Duncan, in the form prescribed by the City of Duncan, from all potential liabilities and claims which may arise as a result of the merchandise tables or display apparatus being on public property.
- (4) Sidewalk Cafes are permitted on public sidewalks in accordance with the following:

- (a) For the purposes of this section sidewalk cafes shall consist of tables and chairs only.
  - (b) Shall only be permitted immediately adjacent to licenced cafes or restaurants, where the term licenced refers to a City of Duncan business licence.
  - (c) A minimum width of 1.2m (4') of public sidewalk must be left fully clear and unencumbered.
  - (d) The tables and chairs may only be placed on the public sidewalk during the hours that the cafe or restaurant is open for business.
  - (e) The owners of sidewalk cafes must formally indemnify and hold harmless the City of Duncan, in the form prescribed by the City of Duncan, from all potential liabilities and claims which may arise as a result of the tables and chairs being placed on public property.
41. The Council may permit or cause to be permitted in writing any person to cause a temporary obstruction on any street or sidewalk or any part thereof for the purpose of removing building, structure, or object, or for the purpose of repairing, altering or constructing any building or for any other necessary work.
42. It shall be unlawful for any person to break, tear up, or remove any planking, pavement, sidewalk, crossing, curbing, macadam, or other surface of any street, sidewalk, or public place within the City or deposit any building material thereon for the purpose of building or otherwise, without having first obtained a permit in writing from the Council to do so; and, in case any such permit be granted, the work of depositing so permitted shall be done under the direction of the Council, and the person to whom such permit shall be granted shall within a time limit to be stated in such permit, complete the work and replace, re-lay, and make good whatever he may have broken, torn up, removed or excavated under such permit or remove such building material. The minimum permit fee shall be \$10.00.
43. Every person to whom a permit is granted under Section 41 or 42 hereof shall erect, and maintain a good and sufficient fence, railing, or barrier, around such obstruction, encroachment, excavation or deposit, in such manner as to prevent accidents, and shall place and maintain upon each extremity of such place, railing, fence, barrier or obstruction or deposit a suitable and sufficient red light at all times between sunset and sunrise, and shall take further care and precaution as the Council may deem necessary and direct for the protection and safety of the public, and shall if required by the Council to do so, previous to commencing any work upon such obstruction, encroachment, excavation or deposit, deposit with the Clerk of the Council, a bond satisfactory to the Council indemnifying the City against any claim, loss or damage which may be occasioned by reason of such obstruction, encroachment, excavation or deposit.

- 44. No person shall run, race, or play in any street or crown or jostle foot passengers within the City, in such manner as to create discomfort, disturbance or confusion.
- 45. No person shall expectorate upon any sidewalk within the City.

- 46. Every person hindering or interfering with the traffic on or obstructing the free use of any sidewalk or street, upon the request of a City of Duncan Bylaw Enforcement Officer, Police Officer or Peace Officer to move away and cease causing such hindrance, interference or obstruction, shall forthwith move away and cease causing such hindrance, interference or obstruction. And in case of any vehicle causing a hindrance or interference with traffic on or obstructing the free use of any sidewalk or street every person owning or in charge of such vehicle shall upon the request and according to the directions of a City of Duncan Bylaw Enforcement Officer, Police Officer or Peace Officer forthwith move such vehicle.

- 47. (1) No person shall place, deposit or leave upon or in any street or other public place any chattel, obstruction, vehicle or other thing which is or is likely to be a nuisance, and no person being the owner or person entitled to the possession or control of any such thing shall permit or suffer the same to remain upon or in such street or other public place. Without restricting the generality of this section, such chattel, obstruction, vehicle or other thing shall not be permitted to remain unmoved or within the immediate vicinity of the said location for a period greater than seventy-two (72) hours.  
(2) The City Administrator may remove or cause to be removed any chattel, obstruction, vehicle or other thing unlawfully occupying any street or other public place in contravention of this Bylaw, and may detain or impound any such thing until the owner thereof shall have paid to the City the costs, fees, charges and expenses of and incidental to such removal, detention and impoundment, including charges for storage; provided that if all the costs, fees charges and expenses shall not be paid within sixty (60) days from the time of such removal, detention or impoundment, the City Administrator may advertise once in a newspaper published and circulating within the City of Duncan his intention to sell or cause to be sold by public auction the thing impounded pursuant hereto after the expiration of five (5) days from the date of the publication of the said advertisement, and if all the aforesaid costs, fees, charges and expenses are not paid before the expiration of the said five (5) days, the City Administrator may proceed to sell any such thing by public auction. If no offers are forthcoming at the public auction, the thing may be disposed of at the discretion of the City Administrator.  
Every effort shall be made to notify the owner of this procedure.  
(3) In addition to all other remedies provided herein, the City may recover in any Court of competent jurisdiction, the costs, fees, charges and expenses mentioned in this Section from the owner of the chattel, obstruction, vehicle or other thing in respect of which the same were incurred.

51. The Council may close or cause to be closed any street or part thereof, or sidewalk or part thereof, or crossing or part thereof, at any time to traffic for the purpose of repairing or altering the same for any other purpose.
52. No person shall be in or upon, or proceed along or lead, ride or drive any animal or drive or propel any vehicle in or upon, through or over any street closed to traffic; every street shall be deemed closed to traffic upon which there appears any written or printed notice by the Clerk of the Council, stating that such street is closed to traffic.
53. Without restricting the generality or limiting the meaning of any words or terms used in any other section of this Bylaw, no person shall build, erect, keep or maintain or cause to be built, erected, kept or maintained, any door-step, porch, verandah, building, fence or other erection or thing, or any part thereof, on any street or highway within the City without the permission of the Council first had and obtained.
54. No person shall construct, erect, or maintain, or cause to be constructed, erected or maintained, any sign, signboard, billboard, or boarding, or any erection or construction connected therewith, over or upon the roof of any building or upon any highway within the City without the permission of the Council first had and obtained.
55. Every doorstep, porch, verandah, building, fence or other erection or thing or any part thereof, standing, projecting into, over or upon or being upon any public street or highway within the City shall be removed by the person or persons by whom the same are or were built, erected, kept or maintained or by the owner of the land in connection with which it exists, at the expense of such person or owner, within

seven (7) days after notice in writing signed by the Clerk of the Council and authorized by the council requiring the removal thereof, shall have been given to such person or owner or left for such person or owner on such premises; and in case such person or owner shall neglect or refuse to remove the same at the expiration of such seven (7) days, the same may be removed by or under the direction of the Clerk of the Council at the expense of such person or owner which same expense shall be recoverable as a debt by the Council in an Court of Competent Jurisdiction.

56. It shall be unlawful for any person to construct, erect or maintain or suffer or permit to be constructed, erected or maintained any business, trading or profession sign or signboard which shall project from any building over any street or highway under seven feet, six inches (7'6") or over fifteen feet (15') above the level of the sidewalk of such street or highway.
57. It shall be unlawful for any person to erect or maintain in, upon or over any street in the City, any awning, the framework of which shall, in any way extend over said street at a less height than seven feet, six inches (7'6") above the sidewalk at any point, or to have thereto a drop or curtain of a greater length or fall than one foot (1') below such framework.
58. No person shall within the City draw or propel, or cause to be drawn or propelled on an street, a load of any description without the same being placed on some sufficient carriage so as to prevent injury to or destruction of the street or any part thereof.
59. It shall be unlawful for any person to drive or propel a vehicle upon any street the wheels of which are equipped with pieces of angle iron or have flanges, spikes or other contrivances attached which may cause injury to the surface of such street.
60. No person shall dig, remove, or carry away any earth, rock, boulders, gravel, sand, stone, tree, shrub or turf from any street, park or lot belonging to the Corporation of the City of Duncan or from any street or public park within the said City without first having obtained a permit in writing from the Council so to do, upon such terms, conditions and regulations as shall be specified in such permit.
61. No person shall injure, remove, disturb, or interfere with the surface or subsoil of any street or sidewalk without having first obtained a permit in writing from the Council to do so, upon such terms, conditions and regulations as shall be specified in such permit.
62. No person shall impede the progress of any funeral procession.
63. It shall be unlawful for any person by use of a megaphone or any mechanical instrument or device or by shouting or noisy conduct to cause a noise on any street within the City.

64. No person shall ride or drive any animal, or drive or propel any vehicle, other than a motor vehicle or trailer, upon any street within the City at a greater rate of speed than thirty (30) miles per hour.
65. It shall be unlawful for any person carelessly, heedlessly, recklessly or negligently to ride any horse or ride, run, drive, or propel any vehicle upon any street in the City of Duncan so that such horse or vehicle shall come in collision with any other animal or vehicle or shall strike against any person.
66. Upon approaching a street crossing or intersection and also in traversing the street crossing or intersection, any person riding or driving any animal, or driving or propelling any vehicle, other than a motor vehicle or trailer, shall ride or drive such animal or propel such vehicle at a rate of speed less than six (6) miles per hour and not greater than is reasonable and prudent having regard to all the circumstances including the weight and size of the vehicle, the nature, condition and use of the street, and the traffic which actually is at the time or might reasonably be expected to be on the street.
67. Every vehicle other than a motor vehicle or trailer and other than a bicycle shall be equipped with one lamp mounted in a conspicuous position on the left-hand side of the vehicle, approximately over a line joining the front and rear wheels of the vehicle and showing a white light readily visible from the highway both in front and in rear of the vehicle. During the period from one-half hour after sunset to one-half hour before sunrise such lamp shall be kept lighted whenever the vehicle is on any highway within the City.
68. No person shall ride or drive a bicycle, tricycle or motor-cycle upon or along any street within the City without having at all times one or both hands on the handlebar of such bicycle, tricycle or motor-cycle, nor shall any such bicycle, tricycle or motor-cycle be ridden on any street within the City at any time recklessly or in any manner or position in which the rider loses control of the machine or might reasonably be expected to lose control of the machine.
69. Every person riding a bicycle, or a tricycle at any time upon any street within the City shall have securely attached thereto a suitable bell, horn or warning device in good working order and the same shall be sounded whenever it is reasonably necessary as a signal or warning to any person of the approach of the bicycle or tricycle.
70. (a) No person shall ride, drive or lead any animal, or move, drive, run or propel any vehicle, except light carriages for the conveyance of children and invalid chairs, upon any sidewalk within the City unless for the purpose of crossing the same, and

no person shall move, drive, run or propel any vehicle across any sidewalk within the City unless such sidewalk be first protected from injury by planks or similar device; PROVIDED that this Section shall not apply to crossing a sidewalk over or upon a crossing which has been especially constructed for that purpose for gaining entrance or exit to or from premises and constructed in a manner satisfactory to the Council

(b) At the discretion of the City Administrator or Deputy Administrator, no person shall propel, coast, ride or in any other way use a play vehicle on any portion of the streets, sidewalks or City owned property in the downtown core bounded by and including Government Street, Duncan Street, Evans Street and Boundary Road."

71. No person shall allow any vehicle or animal to stand upon any sidewalk or boulevard within the City.
72. No person shall cut, saw, break, split, place or pile any firewood, lumber, blocks, rock, stone or other thing, or mix mortar upon any street without express permission of the Council first had and obtained.

73. Bicycles and Tricycles are permitted on trails and roadways in Rotary Park and Centennial Park provided the operators of the bicycles and tricycles give the right of way to foot traffic and they stay on the trails. Bicycles are not permitted near sensitive riparian areas, planted grass or boulevard areas.
74. No person shall construct a driveway for vehicles across any sidewalk unless he has first obtained a permit for the same from the Council, and every such driveway shall be constructed to the satisfaction of the Council.
75. No person shall drag or haul any timber or other article along or upon any street in such a manner that any portion of the same shall rest upon or come in contact with the surface of such street, or any planked, paved or macadamized roadway.
76. No person shall lock the wheel of any vehicle by the method known as "ROUGH LOCKING" or by any method whereby such wheel is prevented from revolving while such vehicle continues in motion on any street.
77. No person shall drag or propel or cause or permit to be dragged or propelled any stone boat upon any street in the City, except for the purpose of making or improving such street.
78. No person shall tie or fasten any animal to any parking meter, sign post, tree, shrub or sapling or to any support or bracket placed around any tree, shrub, or sapling in any street or public place or on any boulevard or grass plot in any street or public place within the City.

79. No person shall suffer or permit any animal to be at large in or upon any street. Every animal shall be deemed to be at large in contravention of this Section unless harnessed to a vehicle or securely tied to some immovable object, or fastened to a rope, rein or chain and ridden or led by some person.
80. No person shall suffer or permit any animal attached to any vehicle to stand or be upon any street unless under the control of some person, or unless securely tied to some immovable object, or to a metallic object of at least sixteen (16) pounds in weight placed upon the ground.
81. No person shall walk or be upon, or place any object or material upon any boulevard or grass plot in any street or public place or public park in the City unless otherwise provided in this Bylaw.
82. No person shall injure or remove any tree, shrub, sapling, plant, flower or grass of or in any boulevard, street, public place or public park in the City.
83. No person shall throw any loose material or suffer or permit any loose material to fall upon any street in the City.
84. No person shall deposit or permit to be deposited upon any street, or public park, or public place in the City any glass crockery, nails, water, oil, gasoline or any solid or liquid material likely to be injurious to the passing of any person, vehicle or animal.
85. It shall be unlawful for any person to throw on any street any vegetable or fruit, or peelings, or other substance liable to cause injury to any person or to throw upon or into any public park or public place or in or upon any street any refuse, paper, sweeping or waste.
86. Every owner or occupier of every building or land fronting on any sidewalk in the City shall remove and keep clear at all times snow, ice, dirt, leaves, other foliage refuse and rubbish from the sidewalk which fronts on such building or land, and shall remove and keep clear at all times all ice, icicles, snow, rubbish, dirt, leaves and other foliage refuse from such parts of the roofs, gutters and cornices of every such building as overhang any sidewalk. Failure to do so shall constitute an offence under this Bylaw, and further, the Municipality, by its employees and others, may enter and effect the removal of such snow, ice, dirt, leaves, other foliage refuse and rubbish as aforesaid at the expense of the person defaulting, and may further order that the charges for doing so, including all incidental expenses, if unpaid on December 31st in any year, shall be added to and form part of the taxes payable on the land or real property fronting on the sidewalk in question, as taxes in arrears.  
(a) The Chief of Police may, by public notice or by the placing of signs on highways prohibit the operation of vehicles which are not equipped with chains or winter tires or sanding devices or in any combination of these which he may consider adequate

87. No person shall plant any tree, shrub, bush or hedge at a distance of less than eighteen inches (18") from any street line within the City.

87.1 No person may allow any tree, shrub, hedge, or bush to grow in such a manner that it:

- (a) encroaches into an adjacent sidewalk, street, or public place;
- (b) impedes the safe or convenient passage of the public along an adjacent sidewalk, street, or public place; or
- (c) is injurious to the bed or construction of an adjacent sidewalk or street.

88. It shall be lawful for the Council to remove or cause to be removed or to trim or cause to be trimmed any trees, shrubs, hedges, or bushes growing or standing on lands adjacent to any highway within the City where in the opinion of the Council the safety or convenience of the public so requires or where any such trees, shrubs, hedges, or bushes become injurious to the road-bed, at the expense of the owners or occupiers of lands on which they grow, which expense shall be charged to the said lands; and to collect the said expenses at the time and in the same manner as taxes against land are collected. Before proceeding to exercise such power, the Council shall give five (5) days notice to the owner or occupier of the said property requiring him to remove or trim the trees, shrubs, hedges, or bushes designated in the notice, and if the owner or occupier does not within the said five (5) days remove or trim the said trees, shrubs, hedges, or bushes or make an application to the County Court Judge, the power so given by this Bylaw may be exercised. If Notice is given to the Council of Appeal to the County Court Judge, the Judge shall decide whether or not the safety or convenience of the public requires that the said tree or trees, shrub or shrubs, hedge or hedges, bush or bushes are injurious to the road-bed and should be removed or trimmed, and whether or not the owner or occupier shall bear the expense, and his decision in the matter shall be final and without appeal.

89. No person shall disfigure any sidewalk or street, every sidewalk or street shall be deemed to be disfigured within the meaning of this section on which any mark, figure, caricature, picture, letter, number or writing is written, drawn or marked or on which a written or printed notice, sign or advertisement picture or paper is placed or affixed.

90. No person shall affix to any tree, telephone pole, telegraph pole, fire alarm or electric light pole or any post, any advertisement, poster notice, placard or sign, without the permission of the Council first had and obtained.

91. No person shall discharge any weapon within the limits of the Corporation of the City of Duncan except upon written authority from the Council.

92. Every person being the owner of any private street or lane or part of a private street or lane shall at all times maintain the same respectively in a cleanly and fit state.
93. No person shall without the permission of the Council first had and obtained construct or place, or permit or cause to be constructed or placed any opening or trap-door in or on any sidewalk or street for the purpose of entrance to any cellar in or under any sidewalk or street; and when permission has been given by the Council to construct or place such trap-door in or on such sidewalk or street the same shall at all times be kept and maintained in a serviceable condition to the satisfaction of the Council.
94. Every area or cellar in or under any street or sidewalk must be covered over with suitable material to the satisfaction of the Council and all openings into such area or cellar from the street or sidewalk must be covered over with iron gratings, the space between the bars of the same not exceeding one-half inch ( $\frac{1}{2}$  inch). No such area, cellar or opening shall be constructed without the permission of the Council first had and obtained.
95. Every person previous to commencing the work of construction of any area, cellar or opening in or under any sidewalk or street in the City shall obtain permission from the Council so to do and deposit with the Clerk of the Council a bond satisfactory to the Council indemnifying the City against any claim, loss or damage which may be occasioned by reason of the construction, existence or use of any such area, cellar or opening.
96. Every person who shall use any area, cellar or opening which shall have already been constructed in or under any sidewalk or street in the City shall on being required by the Council to do so, deposit with the Clerk of the Council a bond satisfactory to the Council indemnifying the City against any claim, loss, or damage which may be occasioned by reason of the existence or use of any such area, cellar or opening.
97. Nothing in this Bylaw shall, or shall be deemed, to affect prejudice or repeal Bylaw No. 459, of the Corporation of the City of Duncan or any of the provisions therein contained which said Bylaw shall have full force and effect notwithstanding any provision therein which may be repugnant to or inconsistent with any provisions of this Bylaw.
98. Bylaw No. 468 and Bylaw No. 804 of the Corporation of the City of Duncan are hereby repealed except so far as the same repeals any Bylaw or any provision of any Bylaw of the said Corporation and all other Bylaws which are repugnant to or inconsistent with this Bylaw other than the said Bylaw No. 459, are hereby repealed to the extent of such repugnancy or inconsistency.
99. No person shall allow any vehicle to stop or stand adjacent to any curb upon which

No person shall move, drive, run or propel any motor vehicle through any portion of a public park within the City, (other than City owned or City employed vehicles) wherein it shall be lawful for the Council to place, and wherein the Council have placed, in such public park signs displaying the statement “VEHICULAR TRAFFIC PROHIBITED”, and further no person shall move, drive, run or propel any motor vehicles through any portion of a public park within the City wherein vehicular traffic is not prohibited at a speed in excess of fifteen (15) miles per hour, and in those portions of a public park it shall be lawful for the Council to place signs displaying the statement “PUBLIC PARK SPEED LIMIT 15 MILES PER HOUR”.

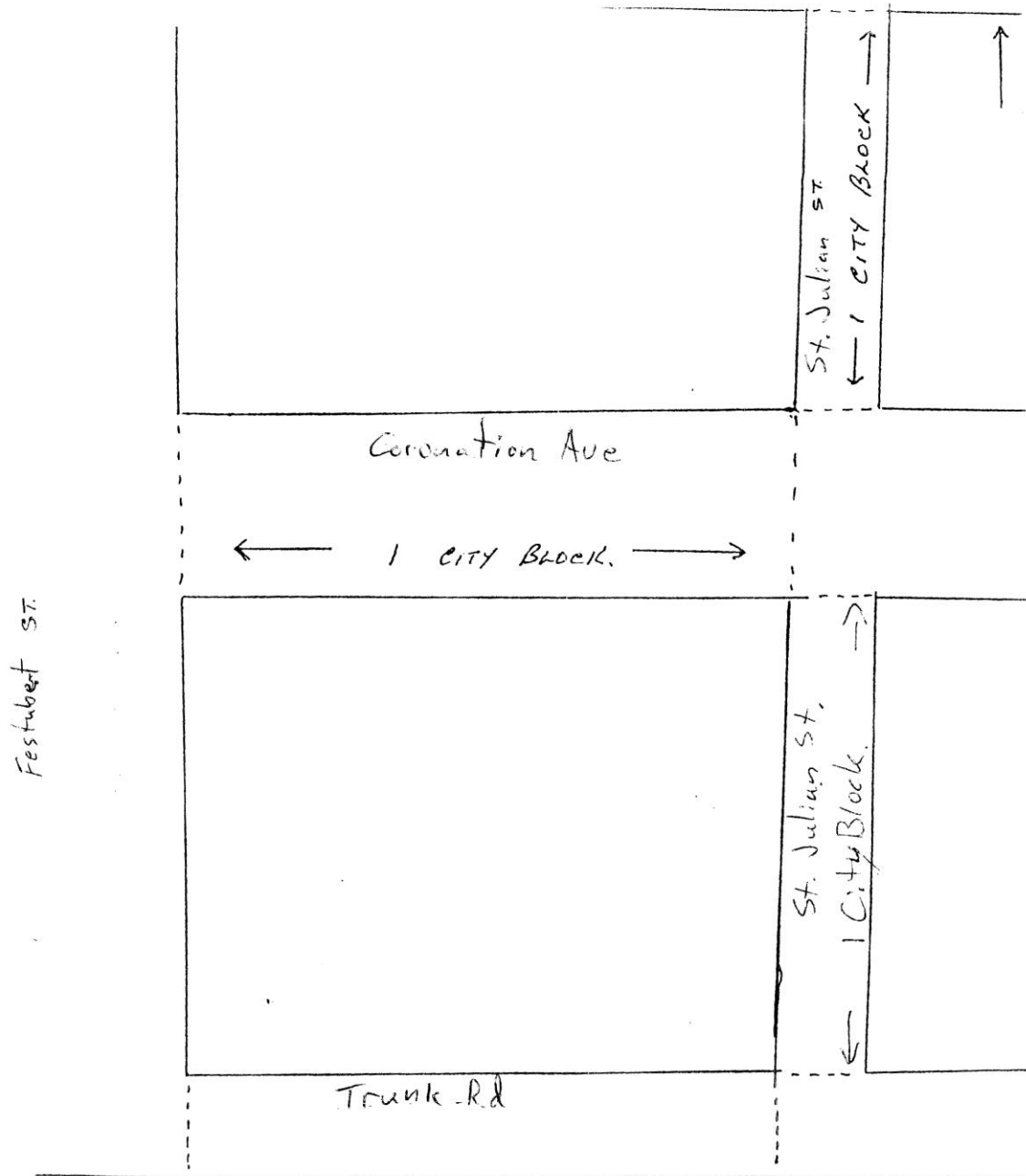
